KEY SUCCESSES

- Abolishment of the commercial discovery bonus
- Allocation of exploration expenses to deductions at the production stage (with successful and unsuccessful exploration)
- Introduction of the right of use of the alternative subsoil tax for offshore and ultradeep fields instead of historical costs recovery charge, export rental tax, mineral tax, and sales tax
- Binding the rates of export customs duty for crude oil to oil prices (which were previously fixed)
- Implementation of transition to combined exploration and production
- Enabling the possibility of synergy (joint project development)
- Simplified access to contracts
- Reduction and simplification of harmonization of project documents
- Reduction of prices for electricity produced by RES facilities through the introduction of the auction mechanism
- Inclusion of technological failures/deviations in equipment and processes in the list of cases of technologically unavoidable gas flaring
- Reducing the base of responsibility for exceeding emissions in cases of gas flaring
- Introducing the concept of "temporary waste storage"
- Exclusion of the production monitoring at the KSCS in winter in ice-covered areas
- Enforcement of the right of companies to allocate quotas for greenhouse gas emissions between their facilities
- Enforcement of the right for operators to choose a method for allocating quotas for greenhouse gas emissions (historical method or benchmarking)



- Abolishment of the requirements for implementing the petroleum products metering system at oil terminals and rescheduling deliveries for petrol filling stations
- Reduction of ECD rates for bitumen (to 15 EUR/ton), fuel oil (to 30 USD/ ton)
- A 7-38% increase in domestic oil prices at oil refineries
- Updated list of regulatory documents valid in the territory of the Republic of Kazakhstan
- Development and approval of 37 national standards and 26 preliminary national standards
- Addressing the issue of applying the national standards in GWS to protect the interests of domestic producers
- Simplification of procedures for the adoption of national and international standards
- Abolition of the requirements establishing the necessity to conduct annual verification of measuring instruments at production facilities
- Abolition of the norms that require the oil compliance evaluation in accredited laboratories of the EEU countries
- Obtaining a satisfactory settlement on the abolition of norms prohibiting the operation of wells with intercolumn pressure
- Approval of the "Sectoral Qualifications Framework" for the oil-gas, oil refining and petrochemical sectors
- Introducing amendments to the Sectoral Agreement on payment of wages in terms of the minimum wage rate in the sector
